Selecting the right photographer for your wedding is just one step, selecting the right collection is the second step. We are happy to work with you to create a custom collection, but have created a couple of popular options to guide you along the way.

All coverage includes time, talent, editing, unlimited images, secure on-line proofing and ordering. Album selections and print purchases are available on-line.

Dates are reserved on a first come first serve basis. A booking fee of \$950 plus 6% tax (SD residents only) and a signed Agreement is required to reserve your date with Cory Ann. The fee will be applied to your total collection rate. Prices subject to change until locked in with a retainer and Agreement.

All commissions include time, talent, and on-line proofing and ordering. Step outside the box, differentiate and show the real you with a photographer who is willing to customize your session. Cory Ann takes pride in bringing out each of her clients personalities.

SESSION \$250
Sessions take place in the Brookings area at a single location. They allow for one-two outfits, one background and are great to get clean classic images.

SESSION & FILES \$1000
Sessions take place in the Brookings area at a single location. They allow for one-two outfits, up to two locations and are great to get clean classic images and a few in another feel of your liking. Includes all hi-res files for printing.

SESSION, FILES & FASHION \$2000
Sessions take place in the Brookings area at a single location. They allow for two-three outfits, two-three locations. Professional hair and make-up are included. Includes all hi-res files for printing.

ESSAY..... \$4000
Document a day in the life. I'll be there to photograph from morning breakfast to bedtime. Photographing all those moments and compiling them in an 8x8 modern book to tell your story. I'll even stay over the night before to get an early start. Includes all hi-res files for printing.



BABY PLAN RATES

Purchasing a Baby Plan will guarantee availability, collection rates and included products as well as 15% off prints.

STANDARD \$725

Includes 3 sessions during the first year including newborn, six months and one year sessions. Includes files printable to 5x7 delivered for all sessions at the end of the plan.

DELUXE \$1250

Includes 5 sessions during the first year including newborn, three months, six months, nine months and one year sessions. Includes files printable to 5x7 delivered for all sessions at the end of the plan.

All sessions are located at the AC Ellis home studio or travel fees will apply. Cannot be combined with any other offers. Missed sessions may not be redeemed after at later times or reimbursed. Sessions include the baby only and not all family members as subjects.



NEWBORN

The longest of the baby plan sessions with images to capture every tiny detail and created to show just how little your new addition is.

2-3 hours



3-4 MONTHS

Your baby will have grown and changed so much by this stage. I will capture your baby with eyes open and head held high.

20-30 min



6-7 MONTHS

Full of personality, sitting up and smiling this is a fun session. Have a bit more fun dressing up your little one and even going outside to explore.

20-30 min



9 MONTHS

Mobile is a good way to describe this milestone. While crawling or walking your child can explore their world and I'll capture their inquisitive nature.

1 YEAR

The final baby plan session to document the first birthday. Images can be used for display at the first birthday party, for invites or even thank you's.

INTIMATE RATES

Intimate sessions are conducted by Cory Ann and are intended to capture the beauty and sexuality of her subjects in an intimate manner. Images are classy and tasteful. With each session all photography talent, editing and proofing is included. Proofing is conducted in-person for local clients and via an on-line gallery for out of the area clients. Unfortunately not all images are optimized prior to proofing, but all images ordered in any format (books, albums, prints, etc.) are fully optimized. Locations for sessions will vary based on the style of your session.

Men and women are invited to do the sessions as well as couples, but no pornography or genitalia will be photographed. Couples may choose the deluxe, fashion, signature or artist session.

ARTIST\$4000

This session is custom designed for you or pulled from our list of concepts we want to execute. We will work together to create an image with a specific never been done before set and theme. Upon completion of your session all props and backgrounds will be destroyed and you image will never be replicated. You will receive a certificate of authenticity with your delivered products. All props, hair and make-up will be provided. An example of the outcome of this type of session is the Winged Nike image that you see in our gallery. Products are purchased separately.

SIGNATURE\$4000

A full day (6-8 hours) with the AC Ellis production team. We design and select our locations, sets, props and attire with you in mind. Many of the items worn will be provided for you from our supply of appealing lingerie and clothing. Comprehensive lighting as well as designs are what take this session above and beyond. This session includes our limited edition book stocked full of images and is not available with any other session. This for the client that would like to have it all.

FASHION\$3000

The fashion session offers you a lot of variety with enough time for multiple outfits, locations, as well as hair and make-up changes. The fashion session includes up to four hours of photography, on-site hair and make-up with a change for each outfit and a lot of fun! This session is great for both albums as well as wall prints.

DELUXE\$2000

One location. Hair and makeup with a change for the second look. This includes up to two hours of photography with time for three to four outfits. This session offers a bit more variety.

STANDARD\$1000

One location for your session including one hair and make-up application. This includes about one hour of photography with one to two outfits. This is great if you have just a few images or a small book in mind, but want to look amazing with our professional hair and make-up as well as photography.

PHOTOBOOTH

The PhotoBooth is an amazingly fun entertainment opportunity for your event. With the booth at your event you are sure to get some hilarious images of all your guests as they take turns clicking the button. It's a wonderful addition to your regular wedding coverage and does not interfere with your hired photographer. And there is no additional cost to you or your guests to obtain the images.

Specifics:

The booth takes up a minimum of 8x8 foot space, but can go to 10x10 feet. A large number of people can occupy the booth at the same time. The booth is rented for your event for a minimum of 4 hours. During this time the booth is supervised by one of our staff. Your guests are free to use the booth at will. We provide the booth, the staff and some fun props to get your guests creativity going.

The images from the booth are delivered to you on digitally in jpg format, within 3 weeks of your event. All images are printable to 5x7. One week after your event all of the images are loaded onto an on-line gallery. You and your guests can view and download images straight from the gallery. The images are print quality and reproduction release is granted for printing as well as internet use like facebook.

PRINT AND PRODUCT RATES

We offers a wide variety of printing options as well as other products to frame and display your images. All products and prints will be available in your shopping cart as well as in our style guide after booking.

Print rates start at \$25 for 7x5 and smaller and \$45 for 10x8. Albums start at \$325 and go up to \$3500. Individual image files as well as complete session and wedding files are available for purchase.



PROOFING OPTIONS

Proofing is how you will view your images after your session. Options include in-person and on-line.

IN-PERSON

For our local clients we will walk you through your images and help you decide what is best for your presentation. We are able to project your images on a wall for actual size viewing. You are always invited to view your images first from our big screen projection system. Not only do you see your images in this stunning quality and environment, but you have the opportunity to discuss display and ordering options.

ON-LINE

Through our on-line system you will have a password protected proofing and ordering gallery included in your collection. This service is hosted and maintained by AC Ellis Inc. and all orders from this service are individually processed by AC Ellis Inc. You will not need to fill the orders of your friends and family, simply direct them to the site and let them select their favorites.

Portrait galleries are active for 7 days and wedding galleries are active for 30 days.

Two-week extension of your gallery.

IMAGE CATALOG

All proofed images are presented in multiple thumbnail sized images per page with corresponding image numbers printed below for easy reference of your images. The image catalog may be purchased through your on-line shopping cart and is included with our deluxe hi-res disc.

REPRODUCTION RIGHTS

Reproduction rights are what AC Ellis releases to you with the purchase of our portrait or wedding high resolution files. As the purchaser of the files you will not receive copyright, but personal reproduction rights. Copyright is very technical, some photographers don't even understand it. But basically if I give you the copyright to your images I cannot use them in any way with out your written permission. I would not even be able to print them for you.

So, while you won't get copyright for your images you will get personal reproduction rights. This will allow you to reproduce the images files for any personal use. No you cannot hire someone else to make your album, but yes you can make your own. No you cannot allow ZYC Dress Shop to use them in their materials as this is commercial use. But you can print and distribute them all you want to family and friends.

PRIVACY POLICY

Personal client information is not sold or distributed to any outside sources for any reason. Cross marketing efforts may include the use of information, but while the distribution of client information may be used the information will not be shared.

Client images are not used for samples on the web or print with out prior authorization of the subject. We take great care in protecting clients privacy. Passwords are placed on client galleries and only you are allowed to distribute it.

If you wish to share your images you may, but you are not prompted, required or expected to at any time.

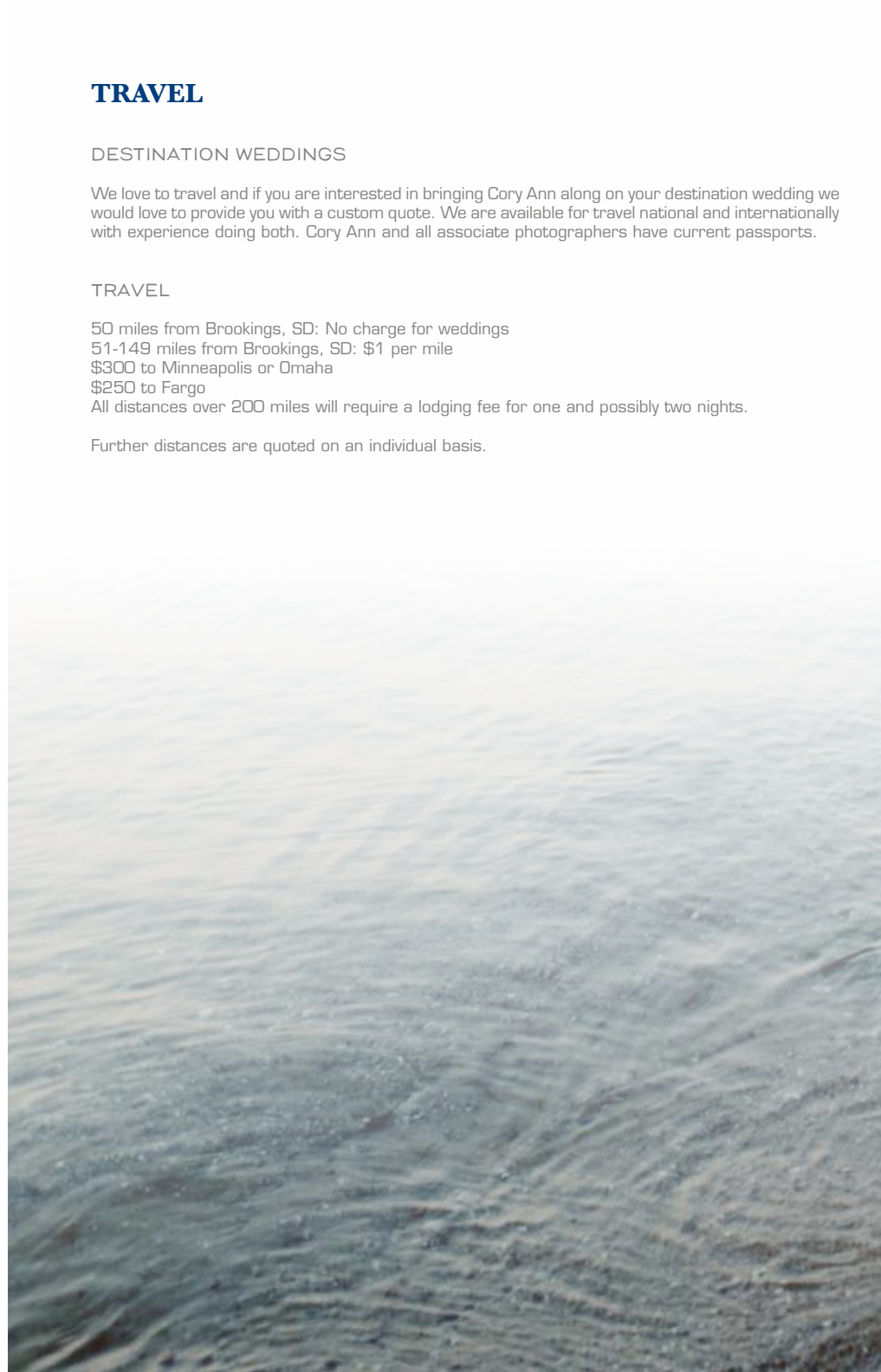
DESTINATION WEDDINGS

We love to travel and if you are interested in bringing Cory Ann along on your destination wedding we would love to provide you with a custom quote. We are available for travel national and internationally with experience doing both. Cory Ann and all associate photographers have current passports.

50 miles from Brookings, SD: No charge for weddings
51-149 miles from Brookings, SD: \$1 per mile

All distances over 200 miles will require a lodging fee for one and possibly two nights.

THE PROCESS AND GENERAL INFO

How the process works...

- You look through all the wonderful stuff we give you, decided that you think our work is fabulous and you just have to book us.
- Call and schedule a meeting if you would like to see some of our work first hand, discuss locations, products, or anything else you want. This can also be done by phone and e-mail if needed.
- Schedule your session. Call with dates that you are thinking would work. Mail in your session fee, which also serves as your retainer, sign your digital Agreement. The retainer is non-refundable.
- Read the client handbook. Pick out your clothes, get pumped up to have some fun. For wedding and intimates please send in your questionnaire.
- Schedule your viewing session to see and order or view your images. Or order your images in your password protected gallery. The passcode and hidden link to your proofs will be e-mailed to you with in two weeks of your session date for most sessions. Intimate sessions have a hidden link and will not be found on the client page.
- Order before your gallery expires. There will be approximately 30-500 images in your gallery. The number is larger with the longer sessions. Weddings vary with coverage.
- Your products are mailed to you. Prints take 3-6 weeks for delivery and other products longer.
- Get ready for your next session because you love your images and the experience!

We know some of you are interested so I'll tell you. We use all digital cameras. We have several and are prepared for most situations. Our tool of choice is a big black box. We consider it just that a tool. It doesn't matter when selecting a photographer what they create with, simply that they consistently create what you are looking for and have back-up equipment.

Because we enjoy using natural light, lighting is of utmost importance. Outdoor sessions are typically scheduled 1-2 hours prior to sunrise and sunset. Indoor sessions are schedule to get the best light with the location often in the afternoon hours. During the short winter months mid-day is the best time to schedule indoor sessions.

All orders are processed by AC Ellis Inc. No image is delivered with out our approval first. We do all my computer work on a big silver box. Again, just another box.

INTIMATE FAQ

You must be 18 years of age to do a intimate session. I recommend that you think about why you are doing the session and who you will show the images to. I do suggest you wait until you are 21. I will not photograph genitalia. male or female.

SESSIONS

Think about the type of images you would like, the desired presentation of your images and also the experience you would like to have. We will have something that is perfect for you. Cory Ann is also offering her Artist Session which are a collaborative effort between the subject and her. You will work together to create a certified one of a kind image.

PRODUCTS

Books, albums and folios are our most popular products purchased from an intimate session. However a full line of products are available to you. We have everything from custom canvas prints to playing cards.

PROPS

We do have some props in our home-studio, but mostly we like more natural images with less props. You are welcome to bring any props or use the accessories that we have on hand. Often we see sports jerseys, ties, hunting equipment, and other things that reflect who the images are also for.

ATTIRE AND ACCESSORIES

Prior to your session we will discuss options with you and help you to bring and select the right items. Lingerie, swimsuits, work clothes, jewelry and high heels are good things to keep in mind. But like stated previously we will work closer with you after your session is booked to select the right items. Our client handbook will give you examples and tips on selecting your outfits.

PORTRAIT FAQ

Most portrait sessions take place on-location. I enjoy creating images in places of special meaning to my clients. There are many wonderful outdoor locations in the Brookings and Sioux Falls area that I use for portrait sessions. Sessions are scheduled in the mornings or evenings in order to utilize natural light.

WEDDING FAQ

WHO WILL BE MY PHOTOGRAPHER?

Your photographer will be Cory Ann. With a qualified second shooter.

WHAT IS CORY ANN'S EXPERIENCE?

I have photographed over 200 weddings in the last nine years. I have spent countless hours developing my skills by practicing, viewing forums, studying, workshops and seminars. I also instruct other photographers when time allows and this allows me to further develop my own skills.

WHAT IF SOMETHING HAPPENS TO CORY ANN?

If something happens to Cory Ann and we are unable to photograph your wedding we will do our best to work with you to find a replacement that we are both happy with. We maintain a large network of photographers to utilize.

WHAT WILL YOU WEAR TO PHOTOGRAPH MY WEDDING?

My staff and I will wear attire that matches the formality of your wedding. We like to blend in so we choose neutral colors.

WHAT IS YOUR STYLE?

Our is distinctive. A mix of documentary and editorial that is ever evolving. Every wedding is different and so are the images.

Creative portraiture during the day is something I excel at. I excel at these because I study and practice how to direct, pose and use light to flatter you the best. I have my MS in Physical Education and have a way of directing after coaching college athletes for 5 years.

We always seem to win over the bridal party and in particular the groom and groomsmen with our quick formals. I have developed and practiced methods of positioning and transitioning that allow us to be very efficient and eliminate the need for hours of formal time.

Being quick, attentive, able to cover a lot of ground, hide off in spaces, and be proactive allows me to capture the real moments as they happen. I stick to what comes naturally, but are able to adapt and fit in with all different groups.

DO YOU HAVE REFERENCES?

Yes, in the way of a raves label on the blog and the love notes section in this guide. A large number of our bookings come from personal referrals, this is the best reference of all. All comments are unsolicited.

ARE YOU A MEMBER OF ANY PROFESSIONAL ORGANIZATIONS?

These are not necessary to qualify a good photographer as many simply require you to pay a fee to be in them. Cory Ann was a member of Wedding Photojournalists Association. This is one of few organizations that requires you to submit images for approval prior to becoming a member, but have let my membership lapse. The other organizations we are in are merely to support the industry.

HOW MUCH TIME DO I NEED?

This depends on the events of your day. If you would like to discuss this feel free to give us a call. Our coverage starts at 8 hours and has gone as long as 14 hours. An average coverage is about 8 hours.

HOW LONG DO FORMALS TAKE?

Never ever more than 45 minutes if all your people are there. The standard 10-15 "must have" groups can be done in 20 minutes typically. No reason to spend your whole day doing these when we can have fun.

WEDDING FAQ CONT.

CAN YOU EXPLAIN PRIVATE PORTRAIT TIME?

This is time when it is just the bride and groom and your photographer. It replicates your engagement session. The reason you should be alone is because others will distract from you having one of those special moments. Often this is the only time of the day that you truly get to yourselves. This can be at the ceremony location or at a separate location of your choice. It's basically just a wonderful opportunity to schedule some fabulous images of the two of you.

WHAT TYPE OF EQUIPMENT DO YOU USE?

We use a variety of big black boxes and very good lenses. We do not skimp on equipment, but also feel that it is only a tool and as long as you like what we produce that is all that matters. We do have the proper equipment for low-light situations also.

DO YOU HAVE BACK-UP EQUIPMENT?

Yes we do. We have multiple full systems that we can use should anything fail. We are also a member of the professional services of my camera maker and can get loaner equipment if needed. We are also insured and if needed can get a replacement.

HOW ARE OUR IMAGES BACKED-UP?

All images are downloaded to the hard drive and backed-up to a second hard drive. Once these copies are made only then are they deleted from the cards. During the editing process periodic back-ups are made to the hard drive. Always there are two copies.

DO YOU HAVE INSURANCE?

Yes I do, like any professional should. I have both equipment and liability insurance. Fully covered and ready to go.

DO WE HAVE COPYRIGHT TO OUR IMAGES?

No, however what you are really hoping to acquire is reproduction rights, and I do sell you the files with this included.

So, while you won't get copyright for your images you will get personal reproduction rights. This will allow you to reproduce the images from the disc for any personal uses. No you cannot hire someone else to make your album, but yes you can make your own. No you cannot allow ZYC Dress Shop to use them in their ads as this is commercial use. But you can print and distribute them all you want to family and friends.

You will get a signed reproduction release from AC Ellis Inc. with your disc that is either purchased separately or included in your collection.

HOW DO I RESERVE OUR DATE?

You call and check availability, dates are reserved on a first come, first booked basis. If your date is available you are sent a link to submit your information on-line. A digital Agreement is sent to you for digital signing and your retainer of \$950 can be mailed into PO Box 684, Brookings, SD 57006. Once we receive both your retainer and Agreement we will send you a confirmation that your date is booked as well as all kinds of information for planning.

WHAT HAPPENS AFTER BOOKING?

You will get some information after booking to help with planning your photography for the day and your engagement session. Your remaining payment is due in two payments 90 days prior to your wedding date and 45 days prior to your wedding date. I will let you know upon receipt and the dates are listed in your Agreement.

AFTER THE WEDDING WHAT HAPPENS?

On approximately your two month anniversary all your images are on-line ready for proofing. You will receive an e-mail notification of your gallery. If an album is in your collection we will give you instructions on how to select your images so that we may begin the design process.

Your digital image files will be delivered 6 months after your wedding date and albums and other products will be delivered according to time lines established for each product.

ENVIRONMENTAL INITIATIVE

No I'm not a tree hugger. :) However, I am aware of my impact on the planet and I would like to minimize it. To help me to better do this I have developed my Environmental Initiative as a guide and mission statement.

OBJECTIVE

Cory Ann Ellis and AC Ellis Inc. will strive to keep their environmental impact to a minimum through reduction of waste, conservation of energy, water and other natural resources, prevention of pollution, and control of chemicals and hazardous waste.

STEPS

1. Reuse: We will do our best to reuse packaging materials before recycling or purchasing new.
2. Recycle: All packaging as well as mail, ink cartridges and other materials will be recycled if possible. A recycling bin will be made available in the office.
3. In order to reduce energy consumption electronics charging and power stations will be established so that there is not a constant draw on power. Computers and accessories will be powered off when not in use.
4. Lights in the office and studio will remain off. When lighting is needed task lighting have been used before overhead lights. Bulbs that are efficient will be selected and installed.
5. Orders that are delivered will be delivered in reusable bags. Shipped orders will be packed and shipped with reused items and fillers.
6. The office and studio all heating and cooling will be localized rather than the entire facility.
7. Draught resistant and dry landscaping will be selected before plants requiring regular watering.
8. At all times the business will operate a vehicle that performs with at least 20mpg minimum, is well maintained, and has the proper exhaust.
9. All natural cleaning methods and agents will used as well as laundry detergents. Chemical agents such as bleach will not be purchased or used. To launder items energy efficient washers and dryers will be used.
10. All measures possible will be taken to maintain a paperless office. Papers that are sent into the studio will be scanned and recycled. When possible digital delivery of statements will be selected over regular mail. Receipt of mail will be turned off when available. Contracts, questionnaires and other studio documents and forms will be delivered, signed and stored digitally only.
11. Telecommuting for employees will be utilized when at all possible. Outsourcing of tasks or allowing for home offices will be utilized before in-house employees.
12. Construction and renovations will all be done with the environment in mind. Selection of materials and methods will include the evaluation and research of energy efficiency.
13. Shipments will be lumped together to minimize trips to the post office and therefore gas consumption. When selecting postage ground shipping will be selected over air. Also for the printing of postage methods will be selected that require less paper.
14. Vendors and printers that are used will be encourage to decrease their impact on the environment. AC Ellis will also select vendors and printers that are already environmental conscience and efficient. Local vendors and printers will be used when possible.
15. Encourage others to reduce, reuse and recycle.
